
Do not install shutter leaning forward or backward!

General Safety Information

- 1. Follow all local electrical and safety codes, as well as the National Electrical Code (NEC) and the Occupational Safety and Health Act (OSHA) in the United States.
- 2. Motor must be securely and adequately grounded. This can be accomplished by wiring with a grounded, metal-clad raceway system, by using a separate ground wire connected to the bare metal of the motor frame, or other suitable means.
- 3. Always disconnect power source before working on or near a motor or its connected load. If the power disconnect point is out-of-sight, lock it in the open position and tag to prevent unexpected application of power.
- 4. Protect the power cable from coming in contact with sharp objects.

Installation of Fiberglass Motorized Wall Shutters

- Shutter frame should be mounted level and squarely on outside wall. Care should be taken not to twist the shutter frame. Never cover shutter with siding or masonry work. Shutter should be mounted so it can be removed any time in case of damage.
- 2. Use tie rod only to test opening and closing of shutter.
- 3. Shutter should operate as freely after installation as it did before.
- 4. Caulking compound is recommended between shutter frame edges and the wall.
- 5. Clean and lubricate shutter at the same time that the fan is lubricated and cleaned.




Figure 2 - Wiring Diagrams


Use These Instructions For Modification of Actuator Model 24N064


Purpose: This procedure is performed to modify the standard single panel shutter motor pack to operate on single panel fiberglass shutter models. Follow this procedure to move the motor crankarm from the gray side of the actuator to the orange side, and to move the rotation limiter from the orange side to the gray side.

- 1. Use pliers to remove crankarm retaining clip (See Figure 3). Save clip.
- Use screwdriver to gently pry crankarm from actuator.
- 3. Remove actuator mounting bolts from motor bracket. Save bolts.
- 4. Remove limiter stop retaining clip (Figure 5)
- 5. Gently pry limiter from orange side of actuator.
- 6. Remove limiter stop screw and re-install on opposite side of limiter.
- 7. Re-install limiter on gray side of actuator.
- 8. Tighten limiter stop screw in position shown (Figure 6).
- 9. Re-install limiter stop cover and retaining clip.
- Re-install actuator so that orange side is against motor bracket (See Figure 3). Re-install mounting bolts.
- 11. Re-install crankarm in the 4 o'clock position on orange side of actuator, through large square hole in mounting bracket as shown (Figure 4).
- 12. Securely re-install crankarm retaining clip.
- 13. Remove linkage screw and nut from linkage end. Save screw and nut.

Installation of Motor

- 1. Remove plastic plug from shutter frame top.
- 2. Attach actuator bracket to shutter frame using 1/4-20 bolt and nut provided, leaving mounting bolt loose.
- 3. Align linkage to right of tie rod, loosen linkage slide (See Figure 7). Note: linkage should be angled in toward louvers.
- 4. Re-install linkage screw and nut, securing linkage to shutter tie rod.
- 5. Make sure shutter louvers are fully closed, and tighten linkage slide adjustment.
- 6. Tighten bracket mounting bolt to frame top.
- 7. Wire actuator as per Figure 2, louvers should open fully when power applied.
