## **Product Description:**

BLDLS38100 is a heavy duty paperboard designed to protect all types of flooring from tracked in dirt and mud, paint spills, dust, construction debris and damage that may occur throughout the construction process. Builder Board<sup>™</sup> is non-staining and breathable allowing moisture to escape for the continued curing of new floors. Made from at least 33 percent post consumer material, this 100 percent recyclable protection lays fast and flat, is tough and reusable.

#### **MSDS:**

Upon review of relevant OSHA regulations and the characteristics of paperboard, a MSDS is not required for paperboard because paperboard falls within the exemptions for a "manufactured article" and "wood products".

First, under OSHA regulations, a MSDS is not required for manufactured "articles" or manufactured items: (i) which are formed to a specific shape or design during manufacture; (ii) which has an end use function(s) dependent on whole or in part upon its shape or design during end use; and (iii) which under normal conditions of use does not release more than very small quantities, e.g., minute or trace amounts, of hazardous chemicals... and does not pose a hazard or health risk to employees. Paperboard is not subject to the MSDS requirements because all three conditions are met.

Second, paperboard is further exempt from the MSDS requirements as a "wood product". Wood products are exempt because their primary hazard is flammability or combustibility, and because the hazard is unmistakable and obvious and does not require further communication. OSHA has stated that "products such as lumber, plywood, and paper are easily recognized in the workplace and pose a risk of fire that is obvious and well-known to the employees working with them". Paperboard shares the relevant characteristics of these products.
